NCI Updates

Szczepanek introduced Grace Mishkin from the NCI.

 Supports trial operations for NCI Cancer Therapy and Evaluation program (CTEP) with focus on NCTN operations

Mishkin opened by giving the group her email address – grace.mishkin@nih.gov.

- Said her message today was primarily one of appreciation
- Many updates coming out of NCI over the last 6 months
 - o Sites have kept on top of them remarkably well

NCI Updates

Grace Mishkin, RN, NCI

- Said message from NCI leadership was that sites have adapted incredibly well under very challenging circumstances
- Also expressed NCI's gratitude for commitment at sites to mission of helping advance cancer treatments
- Mishkin recognized that situation has been difficult
 - Also that NCI has added to difficulty in some cases
 - o Though they are trying to make things easier to cope with

Mishkin said NCI is expanding use of delegation of tasks logs (DTLs).

- Said she has spoken with group before about these
- Noted they had rolled them out without anticipating all of their impacts
- But NCI continues to get feedback from FDA and other regulatory agencies that it is essential they have something of the sort in place for studies
 - o Hence expansion is moving forward
- All phase 2/3 and phase 3 studies activated starting August 2020 are required to have the DTL
- All phase 2 and earlier trials activated October 2020 or later have to have it
- NCI is also encouraging groups to consider adding DTL to already activated studies if there's a chance they will be used for FDA registration
 - Said using a study for new drug registration with FDA will be very difficult if there's no detailed process in place
- Mishkin said she has not been closely involved in DTL project
- But she knows NCI is making efforts to make process easier
- Some details of these efforts were supposed to be released at end of summer
 - o Goal was to have changes rolled out with new activation of DTLs
 - o But have been delays in technical changes
 - o So these improvements have not all been implemented yet
- Said feedback from sites has been important
- More improvement is needed, but improvements already made driven by feedback from sites on workflow issues
- Said she and Andrea Denicoff take that feedback to the tech folks
- Repeated her email address: grace.mishkin@nih.gov

- Sites with suggestions about ways to make DTL process easier should contact her
 - o More people they hear from, more they can use to get changes made
- Also encouraged feedback as improvements are rolled out

Mishkin said many sites had already activated NCI COVID, or NCAP, study.

- Been a top priority for NCI leadership
- Astounded by how quickly it has been taken up across NCTN and NCORP
- Very different trial
 - Burden much more on data collection, as there is not a treatment associated
 - Noted challenges that arise when parts of NCI not used to writing protocols are called on to write them and design case report forms
 - o Thanked sites for their forbearance
- Again, said sites with questions should contact her and she can connect them with the study team
- Invited questions via the Chat box in this session as well

Background

- Fixed price subawards for federal member site payments are now required for the NCI
- Change took effect for both NCTN and NCORP in 2019
- Nonfederal payments are *not* affected by this
 - Nonfederal payments for SWOG studies still go through purchase service agreements with SWOG-CTP

Background

- Fixed-price subawards for federal member site payments are now required by the National Cancer Institute (NCI) for Cooperative Groups
- · Change takes effect:
 - March 1, 2019 for NCTN funding
 - August 1, 2019 for NCORP funding
- Non-federal site payments will <u>not</u> be affected
 - · Non-federal site payments will continue to be distributed via current PSA w/ SWOG-CTP

What remains the same after new mandate

- Payment triggers
 - o Still same enrollment
 - Entering information into OPEN
 - SWOG doesn't accept invoices
 - Unless specifically mentioned in funding memo
- Funding amounts continue to be stated in memos
 - No F&A involved
- Distribution payments processed monthly
 - Come from Theige at group chair's office
 - Accompanied by payment report emails
 - Getting notified payments are coming
 - Have breakdown of what's being paid
 - Patient ID, activity, invoice number to reconcile
- No requirement for additional financial reporting with these subawards

What Will Remain the Same

Federal Payments

- <u>Payment Triggers</u>: Enrollment, OPEN, or as indicated on the funding memo. SWOG will not accept invoices (unless specifically stated on the funding memo).
- . Funding Amounts: As stated on the study funding memo. No F&A added.
- <u>Payment Distribution</u>: Payments will continue to be processed monthly and be accompanied by payment report email.

· Financial/Progress Reporting

· SWOG will not require additional financial reporting or progress reports (at this time)

What has changed

- Fixed-price subawards
 - Separate subawards for NCTN and NCORP studies
 - o Six-year grant cycles shown in slide in blue
 - Subaward amounts for each site vary based on past activity levels
 - If site amount is depleted over 6-year period, can create amendments to increase funding
 - Based on past activity
 - But if site becomes more active, have ways to add funding to your agreement
- Can be additional funding that doesn't fall under one of these subawards
 - o If SWOG has PSA with you, it does not expire
 - Want that mechanism in place if additional funding is needed in future

What Will Change

· Fixed-Price Subawards

- · Separate subawards for NCTN and NCORP study activity
- For NCTN and NCORP subawards, initial subawards will run the entire course of the grant cycle (listed below):
- NCTN grant cycle: 3/1/2019 2/28/2025
- NCORP grant cycle: 8/1/2019 7/31/2025
 Subayyard grant cycle: 8/1/2019 7/31/2025
- Subaward amounts will vary and be based on past activity levels
- If initial amount becomes depleted, SWOG will create amendments (as necessary) to increase funding

Additional Funding

- SWOG will keep PSA's active for funding other than NCTN and NCORP
- In other words, current PSA will not be terminated
- Study Example: S1415 (PCORI funding)

Next step

- Summer 2019 Theige started sending NCORP and NCTN fixed price agreements to sites
- Doing in phases, as SWOG has hundreds of sites
- Based on outstanding amount
- Has executed about 100
- Are other agreements still outstanding
 - o If agreement is outstanding, so are the site's payments
 - o Can't process payments until paperwork is in place
- Going forward, will move to next phase next week
 - o If you haven't heard from Theige, you should soon
 - o Important as part of membership with SWOG to get these financial agreements in place
 - o Red line in slide is the takeaway:

If you don't know if your agreement is executed, don't understand something, or have questions about federal payments, contact Theige.

The Next Step (Updated)

- Starting in the summer of 2019, NCTN and NCORP fixed-price agreements have been sent out to sites (in phases) based on outstanding capitation amounts
- · Dozens of these agreements are still outstanding (which means the payments are, too)
- · Going forward...
- Continue to get more agreements sent out to sites this fall (in phases) and continue to
 process outstanding payments for those sites (once agreements are executed)

Operations & Membership

Szczepanek introduced Dana Sparks, director of operations and protocols.

Sparks presented some general updates.

- Said she is continuously amazed by way staff and sites keep going despite the challenges
 - o Something to be proud of
- Wanted to focus on what has been accomplished during this time
- Had about day and a half notice back in March to plan for 100% telework
- Their 1 IT guy was able to rebuild and repurpose laptops they had in office to support group meeting
 - o Those were for people without VPN connection to use at home
- Most of office has worked from home since March
- In July, some started working partially from office
 - Still very controlled about how many people can be there and about cleaning
- All staff have been trained on needed hardware and VPN access
- Had already planned to expand office space
 - o Now have bigger office with no one there

Ops has hired people for 2 new positions, promoted 4 staff members, and supported 2 lateral staff moves

• Recruitment and hiring is difficult under any circumstances; more so now

Finally completed single sign-on linkage to fully integrate web learning management system

- Not completely done
 - o Web programming still needs to be finished
 - o But background programming done
- Should be much easier to access learning and training materials
- Should also make it easier to engage training manager Lisa Barnstrom to develop new curriculum and training opportunities

Operations

Dana Sparks, M.A.T., Director of Operations and Protocols

- Expecting to expand that over next 2-3 years
- If you have ideas for training that would be particularly helpful, contact Sparks or Barnstrom

Also launched new conflict management disclosure system

- Those who help investigators disclose potential conflicts of interest should be aware that new system maintains old disclosures
 - o So can check and update information already in system
 - Huge time savings
- Was launched this year, and collection process was faster and more complete than in previous system
- Most found it easy to use
- Kudos to Courtney Wille who managed conflict management system and both virtual group meetings
- Lots of work and lots of flexibility needed

Have expanded ability to conduct remote audits

- Between March and September, audit team completed 130 audits
 - o About 90% were remote
- Still have some onsite audits, but very few
- Now documenting standard operating procedures for remote audits
- Clear that remote audits will continue
 - o Requires less travel

New version of CTCAE is now in works.

- Working with NCI to provide them updates
- Also to provide support to sites for process improvements to integrate expedited reporting system from Medidata Rave through CTEP/AERS
- In new reporting process, initial report goes into Rave then is transferred to CTEP/AERS system
- Have also supported sites regarding requirements for COVID-19 expedited reporting
 - Not a ton of this, but a new process

Activated 6 new trials over last 6 months.

- Continue to submit new protocols
 - o 7 proposed protocols now under NCI review
- Continuing to progress and do what needs to be done

As things change, SWOG want to make sure to keep all valuable things learned from this experience.

- Find ways to incorporate those processes that make things easier for sites
- Working within grant requirements and NCTN and NCORP guidance to ensure changes are consistent with NCI
- Also documenting details that will allow us increased flexibility
 - o To help site staff
 - o Hopefully to help patients too
- Sparks noted Chuck Blanke has developed a SWOG innovation working group
 - o To look at changes and ensure group is moving forward in a way that
 - Makes sense
 - Uses available technology to create best practices for the future
- That group will meet in January to nail down recommendations
- Will review ASCO recommendations as well
- Also recommendations from investigators on front line in different practice settings
 - o Rural
 - o Community
 - o Academic
- Sparks said she was looking forward to January meeting
- Thought that overall this experience would make SWOG protocols better and more flexible
- Would allow SWOG to better serve site staff and patients
- Thought group's ability to adapt to these circumstances would strengthen its ability to adapt in the future

Szczepanek remarked that from Sparks's report one would never know all were locked in at home and doing strange things.

"Pandemic schmandemic"

- Said she hated to tell Theige but would add more purchase service agreements to his stack
- International presence is expanding
 - o Bringing Chile and Uruguay on board
 - Brazil to follow
- She also had changes in works with sites moving among membership programs

Barnes had mentioned at spring meeting that SWOG would eliminate credentialing process effective September 1.

- Had to delay that to October 1 because board of governors did not meet in the spring
- Expect to move forward after Saturday BoG meeting
- Should simplify workloads related to credentialing documents

- Many submitted online, through Rave or via CRA Workbench for pre-Rave trials
- Have heard from audit team that many have been documented on paper log at site but staff have not yet submitted in EDC
- Sutter provided tips for submitting form
 - o Don't need to report deviations related to late data submission
 - o Focus on documenting deviations related to patient care
 - Submit form only to report positive test results or pandemic-related deviations
- Questions about what is minor vs. major deviation for this form?
 - o Use qa@swog.org email list to reach SWOG audit team

COVID-19 Deviations

- · Form was released on June 26, 2020
- Many received, but auditors note many are missing
 Tracking on paper log, not entering in the EDC
- Report deviations in regard to patient care, not data submission
- · Only submit for positive test results and/or pandemic related deviations



- Table in slide provides study-specific info on specimens collected
 - Table is a summary and doesn't replace protocols for individual studies
- Goodman said if you can collect only a subset of required specimens, this table will help you decide which specimens are most critical and how to ship those specimens



- Goodman said she reviewed data on specimen submissions as of beginning September
 - Were 736 specimens from 205 patients that had not been submitted because of COVID
- Goodman said repositories haven't noticed much of a drop, so sites are overall able to submit specimens
- Noted they can only identify nonsubmissions as due to COVID if "COVID" is specified within text describing reason specimen not submitted
 - o Goodman said site could just say "COVID" or could specify longer reason
 - Some example of reasons are shown in slide
- Goodman said that even if a site indicates a deviation in specimen submission on a COVID-19 deviation form, it still needs to use that function in Specimen Tracking to resolve the specimen expectation

Unsubmitted Specimens - COVID-19







 - o E.g., shipping investigational agents direct to patients
 - Not a deviation
- If protocol has been revised to extend timeframes, those are not deviations
 - o E.g., if assessments are out of window
- Temporary variances via SWOG memos DO need to be reported
 - Not formal protocol revisions
 - So are considered deviations
- Armstrong reminded group that these deviations won't necessarily result in deficiency
 - o In most cases, wont' be getting a deficiency during audit
 - Primarily a way for SWOG to collect important information

Reporting Covid-19 Deviations

- Variances from protocol requirements previously approved by CTEP are not considered deviations (e.g., investigational agents shipped directly to patient).
- Some protocols have been revised to provide extended timeframes for assessments and/or specimen and data submission for Covid-19 or other extenuating circumstances. Following these updated timeframes do not need to be reported as deviations.
- Temporary variances distributed via memo from SWOG or the NCI must be reported as a deviation.
- In most cases, deviations will not result in a deficiency during an audit.

Armstrong provided guidance on specifics:

- Activities performed by a local healthcare provider
 - o Common now
 - o Done under oversight of responsible investigator
 - Must make sure protocol requirements are followed
 - Often done even during non-pandemic times

 - Examples of things that could be done by a local provider:
 - Labs
 - Imaging
 - Physical exams

radiation if credentialing is not required) are not considered
deviations. Processes must be in place to report required
information to the Responsible Investigator who is responsible for

- Those that don't impact patient safety or compromise study data integrity
- SWOG has best practices document that includes time windows for labs, treatments, assessments
 - o If delay falls within best practices window, not a deviation
- Delays outside of window are usually minor deviations

- Study visits conducted by phone or videoconference are minor deviations

Reporting Covid-19 Deviations

- Minor deviations: do not impact patient safety, compromise the overall integrity of the study data (ability to draw conclusions from the study data)

- Delays in treatment administration, study visits or follow-up assessments
- A single missed assessment (i.e., office visit, lab procedure) or a single missed dosing
- Study visit conducted by phone or video conference

Major deviations:

- Those that could impact patient safety, increase risk, or compromise study
- NCI has issued guidance:
 - Visits for H&P, performance status, toxicity assessment that are needed to determine eligibility must be done in person
 - Can't substitute telehealth
 - o Missed endpoint assessment is a major deviation
 - Multiple missed labs or toxicity assessments add up to major deviation
 - E.g., if patient comes in for 3rd visit in row with no labs or toxicity assessments being done

 - Multiple missed labs, toxicity assessments
 - Substantial treatment delays
 - Failure to collect research specimens (unless lab is closed)
 - Multiple missed visits while patient on treatment

Armstrong echoed Sparks: remote audits are happening.

- But said she's now in hotel room having just completed an onsite audit
- NCI Clinical Trials Monitoring Branch has approved remote audits
- Said NCI working on SOPs for these
 - Thought these would help a lot
 - Some sites are reluctant to have remote audits, but also don't want auditor on site
 - Once there's an SOP, can provide reassurance
- Armstrong noted the remote procedure is similar to the onsite

Remote audits

- NCI-CTMB has approved/endorsed remote auditing due to travel and visitor restrictions related to Covid-19

- Drug accountability records emailed or uploaded and pharmacy review done virtually via video app

- But all communications and exit interview done through technology
- Regulatory docs emailed or uploaded
- Drug accountability records also emailed or uploaded
- Been doing pharma reviews with videoconferencing app
 - Checking inventory and looking at storage conditions

- Armstrong said giving her office access to the site's EMR system is most efficient
 - Easier for auditor and for site
 - Otherwise site has to upload large number of documents
 - SWOG has signed privacy statements and HIPAA statements
 - Noted some sites have gone overboard and SWOG is not willing to sign their documents
 - Now getting access to many more sites than they would have 1 year earlier
- If site won't give EMR access, it needs to upload the records
 - o Upload options:
 - CTSU Source Document Portal

 - Works pretty well, but some glitches
 - Having call on Friday to design document management for audits

- Ideally, EMR access given for the patient case review
- If not, patient records are uploaded for review
- Options for uploading documents into a secure portal CTSU Source Document Portal, SWOG SharePoint site, local site portal
- SWOG has contracted with a company to create an Audit Document Management System within the Office 365 setting to meet our audit needs

- None this size on schedule until after first of year
- Will work with sites and process will get easier


